**Conditions for safe storage:** The lyophilized caspase-3 is stable for 1 year at  $-70^{\circ}$  C. Following reconstitution in water, the enzyme should be aliquoted and immediately stored at  $-70^{\circ}$  C. Avoid multiple freeze/thaw cycles as activity might decrease.
