**Conditions for safe storage:** The lyophilized protein is best-stored desiccated below 0°C. Reconstituted human Eotaxin-2 should be stored in working aliquots at -20°C. For long term storage it is recommended to add a carrier protein (0.1% HSA or BSA). Please prevent freeze-thaw cycles.
